## SURFACE PREPARATION

JOHNSTONE'S INTERIOR TIMBER	Timber should be prepared and polished by sanding. Be sure there is no former coatings of any product (varnish, wax, oil etc.) left before applying. Substrate needs to be studied to establish exact preparation requirements. Check with timber supplier or installer
SOFTWOOD TIMBER	Ensure timber surface is dry, clean and free from dirt and debris prior to application

#### **APPLICATION**

APPLICATOR PAD	Ensure applicator pad has a generous amount of product on the pad. Apply pad to timber surface ensuring libera and even application of product to timber surface. Ensure entire length of the decking board is coated prior to drying.
COVERAGE	Up to 12m2/L dependent on timber porosity
COATS REQUIRED	3
BRUSH-JOHNSTONE'S INTERIOR	1. Use a flat blade paint stirrer to stir product thoroughly before and during use. Please note: This product does not require thinning.
	2. For application around floor edges use a narrow brush or applicator to cut in. Apply to the edges of the area first, then apply along the length of the timber boards. During application keep applied area wet and use gentle strokes along the grain to redistribute the product evenly. Avoid over working the coating as this can result in a patchy finish. Leave to dry for 3 hours then sand gently to achieve a smooth finish. Remove any dust or other contaminants. Apply (at least) two additional coats using the same process.
